19/143 Budget and precept setting for fy 20/21

(a) To receive budget paperwork and agree budget for fy 20/21

Clerk had circulated budget paperwork and supporting information to all members. Members discussed each section of budget and agreed amounts, also agreeing and accepting the recommendations from the Personnel Committee. The budget was then agreed for 20/21 at £150,300.

RESOLVED: That the operational budget for the PC for 20/21 be set at £150,300.

(b) To consider and agree precept requirement for Humberston Village for fy 20/21 for submission to NELC and to receive precept calculations showing house band costings.

Clerk had circulated calculations based on new council tax base figure for fy 20/21 and impact upon precept figures on each house banding. Members agreed precept figure of £85,000 for the fy 20/21.

RESOLVED: That the precept for Humberston Village be set at £85,000 for the fy 20/21. Clerk to Submit request to NELC.
